Insurance Endorsement is required to name Santaluz Maintenance Association as additional insured during the course of construction for a minimum of one million dollars in liability coverage. The certificates of Insurance Endorsement must be presented to the Design Review Office.

#### Encroachments and Easements: (if required)

Estimated landscape revision costs paid.

**Please Note**: Any proposed changes or deviations from the approved plans occurring during construction must be submitted to the Design Review Office for approval on a Plan Change request form prior to the commencement of such changes.
